# I. TELEPHONE SURVEY PROTOCOL

Slightly more than five years after inclusion of the children at the maternity unit, and two years after the survey at 3.5 years, a further telephone survey was conducted on the parents of the Elfe cohort children.

The design of this latest survey questionnaire, like those of the previous surveys, is based on the proposals put forward by the thematic groups, taking account of the pilot survey results, but also of new research questions and requests from the supervisory bodies (notably concerning the "environment" module).

The aim of the 5.5 years' telephone survey was:

- to update information on the child's environment since the 3.5 years' survey (family, social, economic, cultural, dietary, etc.),
- to ask parents about their child-rearing and cultural practices,
- to document the stages of the child's psychomotor development and health events (use of healthcare, targeting of new pathologies of specific interest for the study, such as early puberty, that may be linked to environmental contaminants).

The parents were asked about their child(ren)'s schooling and school in general, as was the case at 3.5 years when they had just started attending school. At 5.5 years, most children had been attending school for at least two years.

The topics introduced or re-introduced at 5.5 years concerned child sociability; the extended family; non-use of healthcare; children's mental health; and in case of separation: changes in child support payments and living arrangements; work-family balance.

To explore mental health, the internationally accepted and recognized Strengths and Difficulties Questionnaire was used [SDQ, for measurement of symptoms of depression, anxiety, hyperactivity and prosocial behaviours between ages 4 and 17 years (Goodman, 1997)<sup>1</sup>].

The survey at 5.5 years was approved by the French data protection authority (CNIL) (authorization no. 915770). Its public interest and statistical quality were certified by the CNIS certification committee (Comité du Label) (visa 2016X718AU).

#### 1. Preamble

Unlike the survey at 3.5 years,<sup>2</sup> but in line with the surveys at 2 months, 1 year and 2 years, both parents were interviewed, one as the "reference parent" and the other as the "cohabiting" or "non-cohabiting" parent.

However, despite a return to interviews with both parents, there is a major difference in survey design and data organization with respect to the surveys at 2 months, 1 year and 2 years: the survey at 5.5 years was not designed around a structural distinction between the "mother" and "father" questionnaires, but rather between the "reference parent" and "cohabiting parent" or "non-cohabiting parent" questionnaires.

This paradigm change addresses the need to satisfy two objectives:

- 1) Adapt the questionnaire structure in line with the protocol of the survey at 3.5 years. Hence:
- either parent could be the reference parent, on condition that he/she lived with the child,<sup>3</sup>
- in cases of alternating custody, both parents were invited to answer a "reference parent" questionnaire,
- the reference parent in the previous survey was contacted first.

Last, note that up until the survey at 2 years, when the father was the reference parent and lived as a couple with the mother, there was no "cohabiting mother" questionnaire since the only reason for such a situation was the mother's unavailability (long absence, inability to answer, father's desire to be the sole reference parent). Under the new protocol, questionnaires could be completed by "cohabiting mothers".

# 2) Facilitate use of data

Whatever the purpose of research, for the surveys at 2 months, 1 year and 2 years, the data from the "mother" and "father" questionnaires must be concatenated in order to obtain the full set of information obtained in the interview with the reference parent. Once the relevant questionnaires have been selected,<sup>4</sup> this involves modifying the prefix of all variables in at least one of the two questionnaires.

Now that a structural distinction has been made – reference parent questionnaire (prefix A05R or A05R2),<sup>5</sup> cohabiting parent questionnaire (prefix A05C) and non-cohabiting parent questionnaire (prefix A05N) – there is no longer any need to modify the prefixes to obtain all the information for the situation associated with one type of questionnaire.

#### 2. Study population and survey waves

In principle, the survey concerned all families who had agreed to participate in the Elfe cohort. The following were excluded from the sampling frame transmitted to the service provider: 1) families that had formally requested to withdraw permanently and 2) families who had not participated since the survey at 2 months, i.e. not surveyed at 1 year, 2 years and 3.5 years.<sup>6</sup>

The sampling frame sent to the service provider included 13,967 families, 2,115 fewer than for the survey at 3.5 years for which 16,082 families had to be contacted (including a non-negligible number of families that had not taken part in the two most recent surveys). <sup>7</sup>

The survey was again conducted on 4 waves of births so that all the children were of roughly the same age when their parents were surveyed. The aim was to ensure that the children were aged at least 5 years 5 months, and at most 5 years 10 months.

The upper age limit was not fixed, however, and depending on the speed of progress in the field and on the participation rate, certain waves were extended beyond the initial deadline, i.e. some interviews were conducted when the children were older than 5 years 10 months.<sup>8</sup>

The successive waves overlapped:

Wave 1: 6 January to 19 April 2017: 2,157 children

Wave 2: 1 February to 3 July 2017: 3,528 children

Wave 3: 25 February to 4 September 2017: 3,995 children

Wave 4: 1 April to 4 September 2017: 4,287 children

#### 3. Protocol for contacting the parents

#### 3.1 Implementation

The Elfe team's data management pole sent the contact details of all families (phone number, email and postal addresses of parents and contact persons) to the service provider, updated in some cases at the time of previous surveys or following other contacts with the families (sending of greetings cards, birthday cards, etc.). As in previous surveys, the database of addresses and telephone numbers was matched for accuracy against the universal directory of La Poste.

At each wave, in the months preceding the survey:

- an initial letter (notification validated by the 'Comité du Label de la Statistique Publique') announcing the survey, worded according to the families' participation "assiduity", was sent to the families by the project team and,
- in the week preceding the survey, all families with an email address received a message from the service provider 1) reminding them that they should have received a letter announcing the survey and, above all 2) giving all the necessary information to make an appointment for the telephone interview on the service provider's website.

The website was developed specifically for the survey by the service provider to optimize participation by enabling families to choose the interview time and, in the event of unavailability at the appointed date/time, to modify the appointment, whatever the method used to arrange it.<sup>10</sup>

The service provider also set up a hotline that the parents could contact by email or by phone. Its main purpose was to provide a personalized response to the questions that families might ask and to make it easy to reschedule an appointment made online or by phone.

During the survey wave, in cases where the father, mother or contact person could not be reached, the service provider implemented specific procedures to recover addresses or telephone numbers via manual searches, follow-up email messages and letters.

#### 3.2 Optimizing initial contact

The list of telephone contacts was first "cleaned" – and hence substantially shortened – by the service provider to remove all wrong numbers.

The numbers that a parent could be contacted on were then called in succession until someone answered. For example, if the father was to be called first, as the reference parent in the survey at 3.5 years, the call was made on his number judged to be most reliable by the Elfe team. If he did not answer on this number, the less reliable numbers were called in succession. Then, if he still did not answer, the numbers of the mother and then of any designated contact persons were called.

For each telephone number, a message was left on the answerphone after the first unsuccessful call. The message was left only on the numbers of the person to be called first (no messages on the numbers of the other parent or contact persons).

The uncontacted parent was called up to 15 times if no contact had been made, and 40 times if contact had been made least once.

After the reference parent had replied, an email was sent to the other parent to arrange an appointment via the website.

#### 4. Types of parents, types of questionnaires

#### 4.1 Definitions

As in the previous telephone surveys, there are three categories of parents, and of questionnaires:

• The REFERENCE parent: he/she lives all the time or part of the time with the child.

For the survey at 5.5 years, the reference parent of the survey at 3.5 years is considered, in principle, to be the reference parent.

In cases of alternating custody, each parent is a reference parent and both complete a reference parent questionnaire. If both take part in the survey, the reference parent in the survey at 3.5 years is reference parent 1. The other is reference parent 2. If only one parent takes part, he/she is necessarily reference parent 1.

The reference parent questionnaire is the most detailed (and includes the questions on the child's health, development and diet).

• The COHABITING parent: he/she lives with the reference parent at the same address as the child. In cases of same-sex parents, <sup>11</sup> the mother' partner can answer a cohabiting parent questionnaire.

The cohabiting parent questionnaire enables this parent to enter the variables that concern him or her specifically, to complete certain question modules only partly completed by the reference parent and to document certain modules concerning the entire household. If the cohabiting parent did not take part, despite being expected to do so, the questions he/she should have answered and which did not concern him/her directly (on housing or the household's living conditions, for example) could be answered by the reference parent.<sup>12</sup>

When both parents took part,

- The following modules had to include the cohabiting parent's answers in order to be fully completed:

EDUCATION (complementary to reference parent's questionnaire)

NURSERY SCHOOL (complementary to reference parent's questionnaire)

CHILD'S/PARENTS' OWNERSHIP OF CULTURAL GOODS, GAMES AND ACTIVITIES (complementary to reference parent's questionnaire)

UV (complementary to reference parent's questionnaire)

MAIN LABOUR MARKET SITUATION (complementary to reference parent's questionnaire)

LIVING CONDITIONS (cohabiting parent only, but two opinion questions are completed by each parent)

**HOUSING** (cohabiting parent only)

PESTICIDES (cohabiting parent only)

NEIGHBOURHOOD (cohabiting parent only)

SLEEP (complementary to reference parent's questionnaire)

- The following modules were completed in full by both parents, with no complementarity:

PARENT'S HEALTH

**EXTENDED FAMILY** 

**TEMPERAMENT**

- The following modules were completed mainly by the reference parent, but certain questions were also asked to the cohabiting parent, without complementarity:

CHILD'S SOCIAL LIFE
CHILD REARING PRACTICES
BODILY AWARENESS

•The NON-COHABITING parent: this is the parent of the Elfe child who does not live at the same address as the child and the reference parent when the child is not in alternating custody.

The structure of the non-cohabiting parent questionnaire is quite similar to that of the reference questionnaire and includes the household composition table, but is different in one key respect: it does not include any of the questions about the child which can only be adequately answered by someone who lives with the child. For example, no questions about the child's health and diet were asked to the non-cohabiting parent.

# 4.2 Summary of situations

The table below describes the various situations encountered and the questionnaires administered in each case:

#### 5. Data dissemination

All the variables of the survey at 5.5 years that can be made available are listed in an Excel document organized into several tabs:

- Tab 1 includes all variables relative to the "reference parent" questionnaires (all variables with prefixes A05R and A05R2).
  - As the questionnaires are identical, the variables with prefixes A05R and A05R2 are presented on the same line and choosing one automatically implies choosing the other.
- Tab 2 includes all variables relative to the "cohabiting parent" questionnaires (all variables with prefixes A05C).
- Tab 3 includes all variables relative to the "non-cohabiting parent" questionnaires (all variables with prefixes A05N).
- Tab 4 includes all "participation" variables (prefix A05X).
- Tab 5 gives the formats of all variables/dictionary of codes.

These variables will be integrated at a later date into the online data platform, using the same categorization.

One variable, TYPQST, characterizes each type of questionnaire:

#### **TYPQST**

- 1 Reference parent with other cohabiting participating parent
- 2 Reference parent with other cohabiting parent who, according to the reference parent, will not participate
- 3 Reference parent without other cohabiting parent and no alternating custody
- 4 Reference parent: alternating custody
- 5 Cohabiting parent
- 6 Non-cohabiting parent
- 7 Reference parent child in care

In the database of responses to the "reference parent" questionnaires, TYPQST is called A05R\_TYPQST and takes the values 1, 2, 3, 4 and 7.

In the database of responses to the "cohabiting parent" questionnaires, TYPQST is called A05C\_TYPQST and takes the value 5.

In the database of responses to the "non-cohabiting parent" questionnaires, TYPQST is called A05N\_TYPQST and takes the value 5.

Note that when the reference parent reported that the cohabiting parent would take part at a later date, the questionnaire administered to the reference parent was filtered to avoid asking the questions intended for the cohabiting parent:<sup>13</sup> The full set of data for cohabiting households necessarily comprises all the variables entered in the "reference parent 1" (prefix A05R) and "cohabiting parent" (prefix A05C) questionnaires.

When the cohabiting parent did participate, to fully reconstitute these modules, the empty A05R\_ variables should be filled in with the information given for the same A05C\_ variables that are not empty.

When the cohabiting parent did not participate even though expected to do so, if the reference parent consented, he/she was asked to answer some of the questions or modules that should have been completed by the cohabiting parent. When this was the case, the variables concerned were entered in the reference parent questionnaire.

The variables A05R\_Q\_COHAB et A05C\_Q\_COHAB provide information on who answered the cohabiting parent questions in the questionnaire.

#### 6. Participation report

The appendix tables present the participation rates for the survey at 5.5 years by type of questionnaire and family situation, overall and by wave.

Participation rates can be considered satisfactory, since in 80% of families, the reference parent at least, were interviewed. The rate is very similar (79%) for the participation of cohabiting parents. For non-cohabiting parents it is much lower, but nonetheless higher than in previous surveys (61%).

Note that for all types of questionnaire, participation declined steadily, although slowly, for successive waves: the participation rate fell from 81.1% in wave 1 to 78.5% in wave 4.

# II. PROTOCOL OF THE "MINIMAL DATA COLLECTION" SURVEY

In order to continue following children whose parents were unable to take part in the telephone survey because they were living outside metropolitan France at the time of the survey, or because they could not be reached, or said they were unavailable but did not wish to drop out, the families were asked to complete a short questionnaire.

Respondents were asked to confirm their phone number and address and to answer around 20 questions.

For the families concerned:

- those living abroad and those living in metropolitan France who had an email address were invited to complete an online questionnaire,

- this same questionnaire, in paper form, was sent to those without an email address living in metropolitan France but for whom we had a postal address.

From mid-May 2017, a questionnaire was sent to non-respondents at Wave 1, then in early October 2017 for non-respondents to Waves 2 to 4. For all waves, this concerned 2,900 people.

Participation results: 200 online responses and 187 paper responses.
